

**RECIPROCAL AGREEMENT BETWEEN  
THE VINES GOLF AND COUNTRY CLUB  
AND  
GOLDFIELDS GOLF CLUB**

**1. RECIPROCAL ARRANGEMENT 01/01/2014**

TheVines Golf and Country Club and Goldfields Golf Club shall provide reciprocal rights and privileges to all members in good standing of the respective Club. Should a member become resident or extended visitor to either town then the Member will not be eligible to participate in reciprocity.

**2. GUEST IDENTIFICATION**

Each travelling Member of the visiting Club must provide to the hosting Club a valid membership card and a letter of introduction.

**3. PRIVILEGES**

- Guest privileges are subject to the rules, regulations and policies of the respective Club. Privileges may be cancelled without notice for failure to comply with the rules and regulation of the respective Club. In the event of special events or extreme demand on the facilities, it may be necessary to temporarily suspend such arrangements.
- Access to member's competition fields will be at the discretion of the General Manager or Club Captain.
- Privileges granted to the guest shall be for a period of thirty (30) consecutive days from the guest's first appearance at the respective Club.

**4. ACCOMMODATION**

Visiting Reciprocal Members will receive 15% off the Daily Rate of any Standard Room

**5. GOLF**

Visiting Reciprocal Members will have access to the Golf Course during weekdays; however for use on weekends or on public holidays, an advanced booking is required, and will be subject to availability and management approval.

**6. GUESTS**

Visiting Reciprocal Members may bring up to 3 guests at the member's guest rate; all other guests will be charged the full green fee rate.

**7. ACCOUNTS/PAYMENT**

Payment for all purchases by a visiting member will be made by cash/credit card or eftpos

**8. DISCONTINUANCE OF RECIPROCAL AGREEMENT**

This agreement may be terminated by either party given one month's advance written notice; otherwise the agreement will run indefinitely.

## Reciprocal Playing Right Agreement Goldfields Golf Club & The Vines Golf and Country Club

1. Each of the undersigned clubs shall extend to any visiting full member of the other club all the privileges to the golf course and other club facilities afforded to its own members. Absentee and overseas members are not permitted to use reciprocal rights.
2. The above mentioned privileges will be exclusive of the regular fee usually charged to visitors and for a maximum of 6 days in any calendar year. Any additional rounds above this limit will be charged the standard visitors rate.
3. Reciprocal members must produce an introductory card or letter upon arrival, which is to include category of membership as well as current handicap. It is also preferable that a letter be forwarded by the reciprocal member's club in advance advising of the impending visit.
4. Reciprocal members shall be subject to all rules, bylaws and other controls in affect at the time of their visit.
5. All purchases for meals, drinks, etc must be paid for in cash/credit card or eftpos.
6. Each reciprocal member shall have the same rights to introduce guests as a member of the host club (subject to course availability) and such visitors shall pay the normal green fee applicable to a guest playing with a member.
7. Reciprocal members and guests will be allowed access to the club competitions at the discretion of the Club Captain. Their eligibility to win trophies will also be at the Captain's discretion and they shall be informed of this prior to tee-off.
8. A member of the reciprocal club residing temporarily in Kalgoorlie for more than one month or on a permanent basis is not entitled to reciprocal privileges beyond the first month of residency.
9. This agreement shall remain in force until such time as either Club, or the 'City of Kalgoorlie Boulder' (being the owner of the Kalgoorlie Golf Course), upon written notice terminates the agreement giving 3 months notice.
